This agreement hereby applies to the City of Copperhill for utility service at the premise named above for operating, repair maintenance, inspection, and data collection, necessary for billing. To use and pay for services received in accordance with the rates, rules and regulations for the City of Copperhill Utilities is now and or hereafter in force and are made part of the agreement. I understand to tamper or destruct property belonging to the City of Copperhill for reasons to receive utilities, is against State Laws and that I will be prosecuted to the fullest extent.

A non-refundable connection fee applies in the amount of \$135.00 for rental property or businessman whom are renting the building. A \$75.00 non-refundable connection fee for homeowners and commercial property owners must be prepaid. I also understand that payment is due upon receipt of bill and if payment is not made by the 25<sup>th</sup> of every month, service(s) will be disconnected, unless a prior arrangement is made and a fee of \$50.00 will be charged for reconnection of service. Failure to receive bill does not relieve responsibility of payment for water used. All bills are due by the 10<sup>th</sup> of each month to avoid a late fee.

All returned checks will be charged a fee of \$35.00 and disconnected- the returned check amount along with the \$50.00 reconnection fee will be applied in addition to the amount of the bill due. This must be paid in cash, no credit cards or checks for reconnecting services.

I understand and agree that I am to notify the City of Copperhill Utility Department prior to any construction work, where any City water or sewer lines might be affected and I understand that the City of Copperhill must have access to meter at ALL times. Meter cannot be covered under any circumstances.
