A RESOLUTION AMENDING RESOLUTION NO. 2-18-25-02 TO AUTHORIZE MILEAGE REIMBURSEMENT AND TO CORRECT THE CERTIFICATION DESIGNATION OF CONTRACTOR TODD DILBECK

WHEREAS, on February 18, 2025, the Board of Mayor and Aldermen of the City of Copperhill, Tennessee, adopted Resolution No. 2-18-25-02, authorizing the City to enter into a contract with Todd Dilbeck for professional services upon completion of successor training; and

WHEREAS, it has been determined that the provision stating "mileage not to be paid by the City" should be removed to allow for appropriate mileage reimbursement; and

WHEREAS, it is necessary to correct the certification designation of Mr. Dilbeck from "certified wastewater plant operator" to "certified water and water distribution operator, with a sewer collection license";

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF COPPERHILL, TENNESSEE:

1. Amendment to Mileage Reimbursement Provision:

The section of Resolution No. 2-18-25-02 stating "mileage not to be paid by the City" is hereby deleted. The City shall reimburse Mr. Dilbeck for mileage incurred while performing his duties, in accordance with the City's standard mileage reimbursement policies.

2. Correction of Certification Designation:

All references to Mr. Dilbeck as a "certified wastewater plant operator" in Resolution No. 2-18-25-02 are hereby corrected to read "certified water and water distribution operator, with a sewer collection license."

3. Ratification of Remaining Provisions:

All other provisions of Resolution No. 2-18-25-02 not specifically amended herein shall remain in full force and effect.

This Resolution shall take effect	immediately upon its passage, the public welfare requiring it.

AGREEMENT FOR PROFESSIONAL SERVICES UPON COMPLETION OF SUCCESSOR TRAINING

THIS AGREEMENT, made and effective into as of theday of, 2025, by and between the CITY OF COPPERHILL, TENNESSEE, a municipal corporation, (hereinafter referred to as "Copperhill") and TODD DILBECK (hereinafter referred to as "Mr. Dilbeck").
RECITALS:
WHEREAS, Copperhill requires the services of an independent contractor to assist with the wastewater treatment plant operations and training, infrastructure projects, and compliance reporting; and
WHEREAS, Mr. Dilbeck is qualified and willing to provide such services to Copperhill; and
WHEREAS, this agreement shall take effect only upon Copperhill's determination that a Wastewater Treatment Plant Operator Trainee has been successfully trained and is fully prepared to assume operational duties; and
NOW, THEREFORE, for and in consideration of the mutual promises and the benefits to be derived therefrom, Copperhill and Mr. Dilbeck agree as follows:
1. <u>Contract Employment Contingency</u> . This agreement shall become effective only after Copperhill determines that a Wastewater Treatment Plant Operator Trainee has been adequately trained and is fully prepared to assume operational responsibilities. The agreement shall be executed and take effect immediately upon such determination.
2. Term and Rate of Pay. The employment of Mr. Dilbeck will continue for one (1) year, beginning on
3. <u>Duties and Responsibilities.</u> During the term of his employment, Mr. Dilbeck will discharge and perform to the best of his ability the following duties and responsibilities: a) Monitor the city SCADA system to ensure tank levels are properly maintained; b) Perform the state monthly operating report (MOR); c) Collect and deliver bacterial samples to the state-certified facility in Etowah, Tennessee; and
d) Oversee the ARCA project for the city's sewer lift station upgrade.

In addition to the duties set forth above, Mr. Dilbeck will, when possible, advise the Wastewater Treatment Plant Operator Trainee who will assume the duties previously held by Mr. Dilbeck is a certified water and water distribution operator, with a sewer collection license.

- 4. <u>Certification.</u> Mr. Dilbeck shall hold the proper certification(s) required by law to perform his duties at the wastewater treatment plant, and he will maintain his certification during his employment by Copperhill. If his certification or license is revoked or he otherwise loses his status to perform his duties at the wastewater treatment plant, this contract will automatically terminate.
- 5. <u>Miscellaneous Provisions.</u> a) The parties by mutual written agreement may amend any provision of this agreement during its term. Any such amendments shall be incorporated into and made a part of this agreement.
- b) This agreement will become effective upon its execution by each party following its approval by Copperhill's Mayor and Board of Aldermen.
- c) The invalidity or partial invalidity of any portion of this agreement will not affect the validity of any other provision.

A RESOLUTION AUTHORIZING THE LEASE OF THE CITY BALLFIELD TO THE GREAT AMERICAN RODEO AT A REDUCED RATE AND ESTABLISHING TERMS AND CONDITIONS OF THE LEASE AGREEMENT

WHEREAS, the Great American Rodeo has expressed interest in leasing the City of Copperhill's Ballfield for the period from June 27, 2025, to July 11, 2025, to host a rodeo event; and

WHEREAS, the standard rental rate for the Ballfield is \$250 per day; however, the Board of Mayor and Aldermen recognizes the cultural and economic benefits that the rodeo event would bring to the community and desires to support such events by offering a reduced rental rate; and

WHEREAS, the City proposes to lease the Ballfield to the Great American Rodeo for a total fee of \$1,000 for the specified period, along with a refundable security deposit of \$1,000, contingent upon the condition of the property post-event; and

WHEREAS, the security deposit will be held in escrow at Peoples Bank of East Tennessee and will be refunded in full provided that the Ballfield is returned in a condition equal to or better than its condition prior to the lease term, as determined by an inspection conducted jointly by the Mayor and the City Maintenance Supervisor;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF COPPERHILL, TENNESSEE:

1. Approval of Lease Agreement:

The City hereby agrees to lease the Ballfield to the Great American Rodeo for the period of June 27, 2025, to July 11, 2025, for a total rental fee of \$1,000.

2. Security Deposit:

A refundable security deposit of \$1,000 shall be required from the Great American Rodeo. This deposit shall be held in escrow at Peoples Bank of East Tennessee.

3. Condition of Property:

The Mayor and the City Maintenance Supervisor shall jointly inspect the Ballfield before and after the lease term to assess its condition. The security deposit shall be refunded in full if the property is returned in a condition equal to or better than its condition prior to the lease term. If damages or required clean-up are identified, appropriate deductions shall be made from the deposit to cover such costs.

4. Authorization to Execute Documents:

The Mayor is hereby authorized to execute all necessary documents to effectuate this lease agreement, consistent with the terms outlined in this Resolution.

5. Effective Date:

This Resolution shall take effect immediately upon its passage, the public welfare requiring it.

A RESOLUTION AUTHORIZING THE SALE OF A SURPLUS FIRE TRUCK AND DONATION OF PROCEEDS TO COPPER BASIN FIRE AND RESCUE.

WHEREAS, the City of Copperhill owns a 1988 Federal Motors Fire Truck, Model E-One, VIN #1F9BBAA87J1037249, with 399,561 hours of service, formerly utilized by Copper Basin Fire and Rescue; and

WHEREAS, this fire truck is no longer in active service and, while still operational, no longer meets the current needs of the volunteer fire department; and

WHEREAS, the City desires to declare this fire truck as surplus property and authorize its sale at auction; and

WHEREAS, Copper Basin Fire and Rescue continues to provide essential fire protection services to the City of Copperhill, and the City wishes to support their ongoing efforts;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF COPPERHILL, TENNESSEE:

1. Declaration of Surplus Property:

The 1988 Federal Motors Fire Truck, Model E-One, VIN #1F9BBAA87J1037249, is hereby declared surplus property.

2. Authorization to Sell at Auction:

Copper Basin Fire and Rescue is authorized to sell the aforementioned fire truck at a public auction, adhering to all applicable laws and regulations governing such sales.

3. Donation of Proceeds:

All net proceeds from the sale of the fire truck shall be donated to Copper Basin Fire and Rescue to support their ongoing fire protection services for the City of Copperhill.
