A RESOLUTION OF THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF COPPERHILL, TENNESSEE, DECLARING A VACANCY ON THE BOARD OF MAYOR AND ALDERMEN DUE TO THE RESIGNATION OF ALDERMAN WILLIAM L. (BILL) STANDRIDGE

WHEREAS, the Board of Mayor and Aldermen of the City of Copperhill, Tennessee, held a special called meeting on March 28, 2025; and

WHEREAS, during said meeting, the resignation of Alderman William L. (Bill) Standridge was formally received and accepted by the Board; and

WHEREAS, Article II, Section 2.05 of the Charter of the City of Copperhill, Tennessee provides that “The board shall by resolution declare a vacancy” upon the resignation of a member of the board;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF COPPERHILL, TENNESSEE:

SECTION 1. That the Board of Mayor and Aldermen hereby acknowledges and accepts the resignation of Alderman William L. (Bill) Standridge, effective March 28, 2025.

SECTION 2. That pursuant to Article II, Section 2.05 of the Charter of the City of Copperhill, Tennessee, the Board hereby declares a vacancy in the office of Alderman.

SECTION 3. That the Mayor and Board of Aldermen shall proceed in accordance with applicable provisions of the City Charter and Tennessee law to fill the vacancy created by this resignation.

SECTION 4. That this Resolution shall become effective immediately upon its adoption, the public welfare requiring it.

A RESOLUTION OF THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF COPPERHILL, TENNESSEE, APPOINTING JEFF THOMAS TO FILL THE VACANCY ON THE BOARD OF ALDERMEN CREATED BY THE RESIGNATION OF ALDERMAN WILLIAM L. (BILL) STANDRIDGE

WHEREAS, the Board of Mayor and Aldermen of the City of Copperhill, Tennessee, at a special called meeting on March 28, 2025, officially accepted the resignation of Alderman William L. (Bill) Standridge and declared a vacancy in accordance with Article II, Section 2.05 of the City Charter; and

WHEREAS, Vice Mayor Jake Reuse made a motion to nominate Jeff Thomas to fill the vacant alderman seat; and

WHEREAS, the motion was duly seconded by Alderman Tamberlyn Tanner and, upon vote, was passed unanimously by the Board of Mayor and Aldermen; and

WHEREAS, the Board desires to formally codify this appointment by resolution;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF COPPERHILL, TENNESSEE:

SECTION 1. That Jeff Thomas is hereby appointed to the Board of Mayor and Aldermen of the City of Copperhill, Tennessee, to fill the unexpired term created by the resignation of Alderman William L. (Bill) Standridge.

SECTION 2. That the appointment of Jeff Thomas shall be effective immediately upon the adoption of this resolution, and he shall serve for the remainder of the unexpired term or until a successor is duly elected and qualified, in accordance with the provisions of the City Charter and applicable law.

SECTION 3. That this Resolution shall become effective immediately upon its adoption, the public welfare requiring it.
